



McDonald's Not Coming To The Woodlands Neighborhood

As I'm sure you've heard by now, the city planning department of Walnut Creek informed the Woodlands Board on January 12th that McDonald's has dropped their pursuit of the former bank building at the corner of Oak Grove and Citrus Drive as their next expansion location. Though McDonald's did not give the city a full explanation as to why they withdrew their application, the recently completed traffic study was likely a significant factor in the decision-making process for the international conglomerate. As most residents know, the intersection in question is a heavily trafficked intersection, and adding a fast-food establishment with a drive-thru at this location had the potential to dramatically escalate already existing traffic woes.

It is almost one full year since the Board learned of the potential McDonald's application. As some Board members, such as President Ed Wohlers and Secretary Elsie Witt, have been on the Board for several years, this was not the first controversy the Board has had to contend with. The Citrus Walk proposal caused much anxiety in the community initially, and the Board learned much from the experience of being a liaison between the community, developers, and various city departments and committees. Ultimately, the project was a success by most standards, and the Board learned some valuable lessons from the experience.

First and foremost was learning to trust in the process and to get involved early. The Board did come under some criticism from residents because we did not take a position on the McDonald's application. When the Board first learned of the McDonald's application, we quickly reached out to city officials, learning who the key players, departments, and committees would be in the vetting process, and then acting as a bridge to the Woodlands community to keep you informed. We also wanted to hear the communities thoughts on the project (which lead to the community meeting on September 25, 2010), as well as give McDonald's an opportunity to convey their side of the story. City officials and McDonald's knew early on that they were dealing with an organized and disciplined unit that would closely monitor developments and hold the process to account.

Employing this "process", knowing and understanding early on significant hurdles existed for McDonald's to overcome, and exercising patience in letting the process unfold, we believe served us and the community better than if we had reacted without trusting the process. I can tell you that as individuals on the Board, none of us wanted a McDonald's restaurant to be the first thing you see when

Crime In The Woodlands - Community Meeting Coming In March

As stated in our January newsletter, in response to neighborhood concerns about increased crime in the Woodlands area we met with the City on January 13th to voice our concerns about this issue. Specifically, several members of the Board and Woodlands resident Chuck Bond met with Mayor Cindy Silva, Councilman Kish Rajan, Police Chief Joel Bryden and City Manager Ken Nordhoff. We appreciate their time and left the meeting very impressed with their commitment to fight crime in Walnut Creek. The following is an excerpt we received Jan. 14th following the meeting from Police Chief Joel Bryden:

“In response to the robberies that have occurred in our City, we have taken steps to try to deter, prevent and stop suspects from committing those crimes. Our detective bureau has been actively investigating several subjects responsible for the robberies in our city and one suspect was taken into custody and charged by the District Attorney’s office. Two others are in custody for crimes outside of Walnut Creek and have been identified as suspects in two of our recent robberies adjacent to downtown.

Specifically related to the Citrus Plaza and the Woodlands neighborhood, our patrol division has been performing extra patrols of the various shopping centers in an effort to demonstrate a high visibility presence in these areas. In addition, our detective bureau and reserve officer division have been conducting covert surveillances of several of the shopping centers. We have also reached out to the businesses in those areas and have been providing crime prevention tips and education on the crimes occurring in these areas (including Citrus Plaza).

We will continue to provide extra patrol through the two business centers adjacent to the Woodlands neighborhood and take any pro-active measures we can to prevent these crimes from re-occurring. In addition, we have plans to organize a business watch meeting with the owners/operators of the various businesses in the centers as well as having a larger community meeting to address issues and expand neighborhood watch groups in the area. We also plan to continue to work with the Concord Police Department in an effort prevent crimes from occurring and arrest those responsible when they do.....”

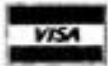
